

**ORDINANCE NO. 840**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANDERSON AMENDING TITLE 2 (ADMINISTRATION AND PERSONNEL), CHAPTER 2.08 (CITY COUNCIL) TO INCLUDE SECTION 2.08.015 PERTAINING TO CITY COUNCILMEMBER COMPENSATION**

**WHEREAS**, Section 36516 of the Government Code authorizes City Councilmembers to enact an ordinance providing them with a salary for their services to the community, which that code section sets at \$300.00 per month for cities with a population of less than 35,000; and

**WHEREAS**, the City of Anderson Councilmembers are currently paid \$50.00 per month, which was an amount established in 1966, over 50 years ago; and

**WHEREAS**, the City Council of the City of Anderson would like to amend the City's code to provide compensation for Councilmembers in the amount authorized under the Government Code.

**NOW, THEREFORE**, the City of Anderson Does Ordain as follows:

**SECTION 1.** Title 2 (Administration and Personnel), Chapter 2.08 (City Council) is amended to add the following section:

**2.08.015- Compensation**

Each member of the city council shall receive a monthly salary in the amount authorized under California Government Code section 36516, as it may be amended from time to time.

**SECTION 2. Severability.** If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of the ordinance. The City Council of the City of Anderson hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause and phrase thereof irrespective of the fact that one or more sections, subsections, sentences, clauses or phrases may be held invalid or unconstitutional.

**SECTION 3.** Publication and effective date.

This ordinance shall be published in accordance with the provisions of Government Code section 36933.

This ordinance shall take effect 30 days after its final passage.

The City Clerk shall certify to the adoption of this ordinance and shall cause it to be posted and/or published in accordance with the law.




